- If you haven't yet completed Responsible Beverage Service training, take the course and print out a certificate to bring to the event.

### What to post on event day

- Your signed SEP in a visible location at the bar or serving area during your event hours.
- Any comments from police or liquor inspectors imposing additional terms and conditions.
- Receipts for the liquor purchased for your event must also be kept on site for inspection by a liquor inspector.
- Any other document you have been directed to post.
- If your SEP requires a security plan, you are not required to display it; however, it must be on site and immediately available should police and/or liquor inspectors request to see it.
- If your event takes place in more than one location, you should also post the name and contact information of an individual who can be in attendance at the event on behalf of the licensee.
